As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

- 1. Any act of Indiscipline, Teasing or Handling with Rudeness.
- 2. Any act that Prevents, Disrupts the Regular Academic Activity.
- Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
- 4. Any Act of Financial Extortion or Forceful Expenditure.
- 5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- 6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
- 7. Any Act of injury or infringement of the fundamental right to the human dignity.
- 8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
- 9. Any unlawful assembly or conspiracy to ragging.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the College, the possible punishments for those found guilty of ragging shall be one or any combination of the following:

- 1. Debarring from appearing in any session test / University Examination
- 2. Suspension from attending classes and academic privileges
- 3. Withdrawing scholarships and other benefits

- 4. Suspension from the college for a period of one month5. Cancellation of admission.

ANTI RAGGING COMMITTEE

Ragging is strictly banned in **SGR GROUP OF INSTITUTIONS/ COLLEGES**. If anybody found indulge in such kind of activities, strict action will be taken irrespective of the extent of the act. Ragging is banned by the Supreme Court of India. In order to prevent such kind of activity in campus, an anti-ragging committee has been formed is operational even before the start of First year classes by the Principal.

SAY NO TO RAGGING

Ragging is neither a means of familiarization, nor an introduction with fresher's, but a form of Psychopathic behavior. Ragging is a violation of Human Rights. Respect for Humanitarian Values. Ragging is a heinous crime, heavily punishable under the law. Ragging may spoil your career forever.

FOLLOWING BEHAVIOUR WITH FRESHERS IS TANTAMOUNT TO RAGGING:

- Force students to perform mass drills.
- Force students to copy class notes for the seniors.
- Force students to run various errands.
- Force students to do menial jobs for the seniors.
- Force students to ask/answer vulgar questions.
- Force students to watch pornographic pictures
- Force students to drink alcohol, scalding tea, smoking, etc.
- Force students to perform acts which can lead to physical injury/ mental torture or death
- Force students to perform acts with sexual overtones, including homosexual acts.

Objectives of Anti Ragging Committee

Anti-Ragging Committee will be the Supervisory and Advisory Committee in preserving a Culture of Ragging Free Environment in the college Campus. Responsibilities of Anti Ragging Squad

Anti-Ragging Squad will be working under the Monitoring of Anti Ragging Committee and will seek advice from the Anti-Ragging Committee. The functions of Anti-Ragging Squad will be to keep a vigil and stop the incidences of Ragging, if any, happening / reported in the places of Student aggregation including, Classrooms, Canteens, Buses, Grounds, Hostels etc. The Squad will also educate the students at large by adopting various means about the menace of Ragging and related Punishments there to. A gamut of positive reinforcement activities are adopted by Anti-Ragging Squad for orienting students and molding their personality for a better cause. They shall work in Consonance and Guidance of Anti Ragging Committee.

Observation and Directives of the Supreme Court:

The Supreme Court of India has observed that enrolment in academic pursuits or a campus life should not immunize any adult citizen from the penal provisions of the laws of the land.

According to the directions of the Supreme Court if any instance of ragging is brought to the notice of the administration or the faculty, it is legally binding on the institute to report the matter to the Local Police.

Our Directives to the seniors:

Any interaction between fresher's and seniors where the seniors are friendly, welcoming and non-aggressive is encouraged.

Seniors may solicit participation in clubs and other activities by announcing promotional events at well designated times and places. However, no fresher should be forced to attend. Participation by fresher's can only be voluntary
